**Subject:- Grant of Fresh Affiliation in Four Year Integrated B.A. B.Ed. and B.Sc. B.Ed. Courses for the session 2017-2018.**

Dear Sir/Madam,

This is in reference to your application and Inspection Report on the subject cited above, in this connection this to inform you that on the basis of Inspection Report and recommendation of the Affiliation Committee, the Hon'ble Vice-Chancellor has been pleased to grant **Fresh Provisional Affiliation** to your College in **Four Year Integrated B.A. B.Ed. Course (with 50 Seats-One Unit)** and **B.Sc. B.Ed. Course (with 50 Seats-One Unit)** as per N.C.T.E. norms for the Session 2017-2018, subject to fulfillment of the conditions as mentioned below:-

1. "To follow and observe the University Act, Statutes, Ordinances, Regulations, Rules and Instructions framed, amended, adopted and issued from time to time in General and specifically relating to :
  - (a) Admissions of students in the B.A. B.Ed. Course and B.Sc. B.Ed. Course will have to be made up to the allotted seats.
  - (b) To follow curricula/Courses of study as prescribed by the University from time to time including scheme of examinations and conduct of examinations.
  - (c) Appointment of Teaching/Sports/PTI/Library Staff."
2. (i) All the conditions as prescribed by the State Govt. in the N.O.C. No. F.24(26)NOC 17-18 / B.Ed./Akashi/2017/243 dated 8-05-2017 and NCTE recognition letter No. NRC/ NCTE/ Recognition/2016/162262-66 dated 21<sup>st</sup> November, 2016 will have to be followed and compliance report of fulfillment of all conditions will be submitted within two months.
  - (ii) Staff: Appointment of permanent and qualified Principal and teaching staff on the fulltime basis selected by a duly constituted Committee as per the norms of NCTE/State Govt./UGC before the commencement of the session.
  - (iii) That the reserve fund for an amount equal to three months salary of the Teachers and Staff be created within one year from the date of issue of this order and maintained in the form of FDR in favour of the management/institution, for a period of not less than sixty months (Five Years) in a Nationalized Bank.
  - (iv) Building: Construction of sufficient building as per guidelines of the NCTE/University provisions, play grounds and hostel building.
  - (v) Library: Year wise development of college Library and provision of funds for journals and magazines be made.
  - (vi) Endowment Fund: Submit an attested copy of the FDR amounting to Rs.2.00 lacs created with the joint signature of the Registrar, MDS University, Ajmer and College towards Endowment Fund within one year from the issue of this affiliation letter.
  - (vii) Faculty Members: Appointments of faculties as per norms of NCTE should be made.
  - (viii) To make compliance and fulfillment of the conditions laid down in your affiliation letter and submit it **within two months** from the date of issue of this letter.
3. To provide the information as asked for by the University from time to time including Statistics etc.
4. To follow strictly rules and regulations and amendments governed by the University & NCTE from time to time.
5. महाविद्यालय सत्र 2017-2018 में चार वर्षीय इंटीग्रेटेड बी.ए. बी.एड. एवं बी.एससी. बी.एड. पाठ्यक्रमों की नवीन अस्थायी सम्बद्धता हेतु जारी पत्र की दिनांक से दो माह में उक्त पत्र में अंकित शर्तों की विन्दुवार अनुपालना रिपोर्ट विश्वविद्यालय को भिजवाया जाना सुनिश्चित करें।

6. महाविद्यालय को सत्र 2017-2018 में चार वर्षीय इंटीग्रेटेड बी.ए.बी.एड. पाठ्यक्रम में (50 सीट-एक यूनिट) व बी.एससी. बी.एड. पाठ्यक्रम में (50 सीट-एक यूनिट) की नवीन अस्थायी सम्बद्धता विश्वविद्यालय पत्रांक 6551 दिनांक 10.04.2018 के क्रम में विश्वविद्यालय रसीद सं. 0001024 दिनांक 19.04.2018 के द्वारा आर्थिक दण्ड रु. 50,000/- विश्वविद्यालय कोष में जमा कराये जाने के पश्चात् इस आधार पर प्रदान की गई है कि महाविद्यालय 60 दिवस में निम्नानुसार कमियों की पूर्ति कर प्रमाणिक दस्तावेज विश्वविद्यालय को भिजवाया जाना सुनिश्चित करें, अन्यथा आगामी सत्र 2018-2019 में प्रवेश पर रोक रहेगी:
1. महाविद्यालय में सत्र 2017-2018 में चार वर्षीय इंटीग्रेटेड बी.ए.-बी.एड. एवं बी.एससी.-बी.एड. पाठ्यक्रमों (100 सीट-दो यूनिट) हेतु विश्वविद्यालय द्वारा अनुमोदित नियुक्त शिक्षक ही नियुक्त है। एनसीटीई के निर्धारित मानदण्डानुसार प्राचार्य/विभागाध्यक्ष सहित 16 शिक्षक नियुक्त दर्शाये गये हैं। नियुक्त समस्त शिक्षक राष्ट्रीय अध्यापक शिक्षा परिषद (विनियम मानदण्ड तथा क्रियाविधि) (संशोधन) विनियम, 2017 के प्रावधानानुसार नेट/सेट नहीं होने के आधार पर निर्धारित योग्यताधारी नहीं है। निर्धारित योग्यताधारी शिक्षकों की नियुक्ति किया जाना सुनिश्चित करें।
  2. महाविद्यालय को उक्त पाठ्यक्रमों की नवीन अस्थायी सम्बद्धता हेतु जारी पत्र की दिनांक से एक वर्ष की अवधि में कुलसचिव, मदस विश्वविद्यालय, अजमेर एवं महाविद्यालय के संयुक्त खाते की संयुक्त हस्ताक्षर युक्त रु. 2.00 लाख की अक्षय निधि कोष की एफडीआर की सत्यापित प्रति विश्वविद्यालय को भिजवाना अनिवार्य है।
  3. महाविद्यालय सत्र 2017-2018 में उक्त पाठ्यक्रमों में प्रवेशित विद्यार्थियों की यूजीसी/राज्य सरकार/विश्वविद्यालय नियमानुसार कालांश व उपस्थिति की अनिवार्यता सुनिश्चित करें।

It may be noted that the application for extension in provisional affiliation/ fresh/permanent affiliation (as the case may be) for the session 2018-2019 along with the copy of original Receipt & detailed fee statement, after depositing prescribed fee by Demand Draft in the University (failing which the application form shall be treated as cancelled or otherwise in the case of part submission of the necessary fee the part payment so made shall be forfeited and the said application form shall be rejected) together with a report about the fulfillment of the conditions of the affiliation up to 31st December, 2017.
